CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS in the MALHEUR LAKE BASIN for SUPPLEMENTAL IRRIGATION OF 218.6 ACRES.

This right was perfected under Permit G-9310. The date of priority is MARCH 11, 1981. This right is limited to 2.34 CUBIC FEET PER SECOND, BEING 0.44 CFS FROM WELL 1 AND 1.90 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NE 1/4 SE 1/4, SECTION 29, NE 1/4 NE 1/4, SECTION 32, T 22 S, R 33 E, W.M.; WELL 1 - 1570 FEET NORTH AND 10 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 29, WELL 2 - 590 FEET SOUTH AND 1280 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 32.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
