CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN C. & JOYCE A. LAGLER 23975 HIGHWAY 20 EAST BEND, OREGON 97702

confirms the right to use the waters of ROCK CREEK & ROCK CREEK RESERVOIR, CONSTRUCTED UNDER PERMIT R-7989, a tributary of MALHEUR LAKE, for the purpose of IRRIGATING 400.0 ACRES AND SUPPLEMENTAL IRRIGATION 332.9 ACRES.

The right has been perfected under Permit 44659. The date of priority is OCTOBER 24, 1949 FOR 5.0 cfs and SEPTEMBER 18, 1950 FOR 4.2 cfs. The right is limited to not more than 9.2 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 16, T 22 S, R 33 E, W.M.; 210 FEET NORTH & 1340 FEET EAST FROM SOUTHWEST CORNER SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
