CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN C. AND JOYCE A. LAGLER STAR ROUTE 2, BOX 15141, HIGHWAY 20 BURNS, OREGON 97720

confirms the right to use the waters of ROCK CREEK RESERVOIR, ENLARGED UNDER PERMIT R-8305, a tributary of MALHEUR LAKE, for the purpose of SUPPLEMENTAL IRRIGATION OF 732.9 ACRES.

The right has been perfected under Permit 46002. The date of priority is JANUARY 8, 1981. The right is limited to not more than 258.0 ACRE-FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 16, T 22 S, R 33 E, W.M.; 210 FEET NORTH AND 1340 FEET EAST FROM THE SW CORNER OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
