confirms the right to use the waters of A WELL in the SPRAGUE RIVER BASIN for IRRIGATING 63.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 277.1 ACRES.

This right was perfected under Permit G-8603. The date of priority is MAY 7, 1979. This right is limited to 2.30 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 NE 1/4, SECTION 29, T 36 S, R 14 E, W.M.; 200 FEET SOUTH AND 3000 FEET EAST FROM NORTHWEST CORNER OF SECTION 29.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

On the lands listed as supplemental, this right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
