CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO WELLS in the WEST FORK WILLIAMS CREEK BASIN for SUPPLEMENTAL IRRIGATION OF 19.0 ACRES.

This right was perfected under Permit G-9697. The date of priority is SEPTEMBER 11, 1981. This right is limited to 0.16 CFS FROM WELL 1 AND 0.08 CFS FROM WELL 2 WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM WELL 1 TO BE MADE UP BY APPROPRIATION FROM WELL 2, AND SHALL NOT EXCEED 0.24 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SW 1/4 SW 1/4, SECTION 5, T 39 S, R 5 W, W.M.; WELL 1 - 1150 FEET NORTH AND 400 FEET EAST; WELL 2 - 660 FEET NORTH AND 60 FEET EAST; BOTH FROM THE SOUTHWEST CORNER OF SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use of water shall be limited when it interferes with the prior SURFACE WATER rights of others.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant, is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
