CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

A. MILES LODMELL 120 EAST BIRCH WALLA WALLA, WASHINGTON 99362

confirms the right to use the waters of THREE SPRINGS, a tributary of MILL CREEK, for DOMESTIC USE FOR THREE FAMILIES INCLUDING IRRIGATION OF UP TO ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN EACH.

This right was perfected under Permit 50939. The date of priority is JUNE 12, 1989. This right is limited to 0.02 CUBIC FOOT PER SECOND FROM SPRING 1 SUPPLEMENTED BY WATER FROM SPRINGS 2 AND 3, or its equivalent in case of rotation, measured at the points of diversion. PROVIDED THAT ALTHOUGH DECLARED HEREIN TO BE FOR SUPPLEMENTAL USE FROM TWO OF THE SPRINGS, USE OF WATER FROM SPRING 3 MAY BE EXERCISED AT TIMES WHEN THE WATER SYSTEM FROM SPRING 1 IS SUBJECT TO FREEZING CONDITIONS, PROVIDING THE QUANTITY DIVERTED FROM ALL SOURCES DOES NOT EXCEED THE LIMITATION ALLOWED HEREIN.

The points of diversion are located as follows:

SE 1/4 NW 1/4, SECTION 21, T 6 N, R 38 E, W.M.; SPRING 1 -1800 FEET SOUTH AND 2357 FEET EAST; SPRING 2 - 1840 FEET SOUTH AND 2547 FEET EAST; SPRING 3 - 1945 FEET SOUTH AND 2500 FEET EAST, ALL FROM THE NW CORNER OF SECTION 21.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 NW 1/4 - 3 FAMILIES SECTION 21 TOWNSHIP 6 NORTH, RANGE 38 EAST, W.M.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
