CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NEIL M. THURESSON 5907 UPPER COW CREEK ROAD AZALEA, OREGON 97410

confirms the right to use the waters of COW CREEK, a tributary of THE SOUTH UMPQUA RIVER, for IRRIGATING 1.4 ACRES.

This right was perfected under Permit 27501. The date of priority is JULY 25, 1961. This right is limited to 0.01 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NE 1/4, SECTION 33, T 31 S, R 4 W, W.M.; 970 FEET SOUTH AND 50 FEET EAST FROM THE N 1/4 CORNER OF SECTION 33.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SEVENTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NE 1/4 0.2 ACRE NE 1/4 NW 1/4 1.2 ACRES

SECTION 33

TOWNSHIP 31 SOUTH, RANGE 4 WEST, W.M.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 0.01 cubic foot per second.

The following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the user is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 6, 1983, and together with Certificate 51966, supersedes Certificate 36165, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
