CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ASA L. BROWN
HAINES, OREGON 97833

confirms the right to use the waters of MARBLE or GRAVEL CREEK and WILLOW CREEK, a tributary of POWDER RIVER, for IRRIGATION OF 421.61 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The date of priority is 1864 FOR 25 ACRES, 1901 FOR 18 ACRES, 1858 FOR 173.8 ACRES, 1894 FOR 80 ACRES, TRACT 1; OCTOBER 12 1864 FOR 60 ACRES, 1868 FOR 41.81 ACRES, 1883 FOR 23 ACRES, TRACT 2.

The use is limited to 1/40TH OF ONE CUBIC FOOT PER SECOND PER ACRE or its equivalent in case of rotation, measured at the point of diversion from the source.
