CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN, for IRRIGATING 5.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 127.5 ACRES.

This right has been perfected under Permit 44691. The date of priority is OCTOBER 24, 1979. This right is limited to 1.66 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 1, NW 1/4 NW 1/4, SECTION 16, T 35 S, R 1 W, W.M.; 48 FEET SOUTH AND 120 FEET EAST FROM THE NW CORNER OF SECTION 16.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
