CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LON OR CONNIE YOUNG 12201 WILLIAMS HIGHWAY GRANTS PASS, OREGON 97526

confirms the right to use the waters of APPLEGATE LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-7810, a tributary of APPLEGATE RIVER, for SUPPLEMENTAL IRRIGATION OF 22.0 ACRES.

This right was perfected under Permit 50257. The date of priority is APRIL 20, 1987. This right is limited to 22.0 ACRE FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LAUREL HILL DITCH - SW 1/4 NE 1/4, SECTION 1, T 38 S, R 5 W, W.M.; 100 FEET NORTH AND 550 FEET EAST FROM CENTER 1/4 CORNER OF SECTION 1; APPLEGATE LAKE RESERVOIR - S 1/2 SE 1/4, SECTION 25, T 40 S, R 4 W, W.M.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The water user shall comply with the terms and conditions of CONTRACTS 1-07-10-W0297 AND 1-07-10-W0298 dated 13TH of JULY, 1981 between THE BUREAU OF RECLAMATION AND APPLICANTS AND CLIFFORD E. AND CREDELLIA D. WILLSON, OR SATISFACTORY REPLACEMENTS. A COPY OF THE CONTRACTS ARE ON FILE WITH THE WATER RESOURCES DEPARTMENT.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4 22.0 ACRES
SECTION 35
TOWNSHIP 37 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
