CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO UNNAMED SPRINGS, CREEK SPRING AREA, AND A RESERVOIR, CONSTRUCTED UNDER PERMIT R-10905, a tributary of WEST FORK DAIRY CREEK, for DOMESTIC USE FOR THREE FAMILIES AND IRRIGATION OF 4.3 ACRES.

This right was perfected under Permit 50259. The date of priority is MAY 27, 1987. This right is limited to 0.06 CUBIC FOOT PER SECOND, BEING 0.01 CFS FROM THE SPRINGS FOR DOMESTIC, AND 0.05 FROM CREEK SPRING AREA AND RESERVOIR FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source. **No water shall be appropriated FROM DIRECT FLOW during the period JULY 31 to SEPTEMBER 15.**

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 19, T 2 N, R 3 W, W.M.; SPRING 1 - 1085 FEET NORTH AND 475 FEET EAST; SPRING 2 - 1055 FEET NORTH AND 485 FEET EAST; RESERVOIR - 850 FEET NORTH AND 350 FEET EAST; CREEK SPRING AREA - 845 FEET NORTH AND 400 FEET EAST; ALL FROM THE SW CORNER OF SECTION 27.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SW 1/4 4.3 ACRES DOMESTIC 3 FAMILIES  
SECTION 19  
TOWNSHIP 2 NORTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
