## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM A. BARTON C/O MRS. BARTON P.O. BOX 1337 GOLD BEACH, OREGON 97491

confirms the right to use the waters of THREE UNNAMED STREAMS AND A SPRING, tributaries of THE ROGUE RIVER, for DOMESTIC USE FOR ONE FAMILY, STOCK WATER AND IRRIGATING 4.0 ACRES.

This right was perfected under Permit 50127. The date of priority is JULY 8, 1987. This right is limited to 32.65 GALLONS PER MINUTE or its equivalent in case of rotation, measured at the point of diversion from the source, BEING 2.0 GPM EACH FROM POINTS OF DIVERSION A, B, C, AND THE SPRING (F) FOR STOCK WATER, 22.4 GPM FROM POINT OF DIVERSION E FOR IRRIGATION AND 2.25 GPM FROM POINT OF DIVERSION D FOR DOMESTIC USE.

The points of diversion are located as follows:

POD A - LOT 1 NE 1/4 NE 1/4; POD B, C, D, E AND SPRING (F) -SW 1/4 NE 1/4, ALL IN SECTION 20, T 36 S, R 14 W, W.M.; A - 650 FEET SOUTH AND 1339 FEET EAST, B - 1883 FEET SOUTH AND 1125 FEET EAST, C -2126 FEET SOUTH AND 899 FEET EAST, D - 1680 FEET SOUTH AND 687 FEET EAST, E - 1888 FEET SOUTH AND 689 FEET EAST, F - 1980 FEET SOUTH AND 482 FEET EAST; ALL FROM THE NORTH 1/4 CORNER OF SECTION 20.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 NE 1/4 STOCK WATER SE 1/4 NW 1/4 1.0 ACRE SW 1/4 NE 1/4 3.0 ACRES DOMESTIC AND STOCK SECTION 20 TOWNSHIP 36 SOUTH, RANGE 14 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
