CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ANNE AND REILLY KALLES
233 JACKSON CREEK ROAD
TILLER, OREGON 97484

confirms the right to use the waters of JACKSON CREEK, a tributary of SOUTH UMPQUA RIVER, for DOMESTIC USE FOR ONE FAMILY INCLUDING THE IRRIGATION OF LAWN AND NON-COMMERCIAL GARDEN NOT TO EXCEED ONE-HALF ACRE.

This right was perfected under Permit 51170. The date of priority is NOVEMBER 29, 1990. This right is limited to 0.01 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source. NO WATER SHALL BE APPROPRIATED DURING THE PERIOD FROM JULY 1 THROUGH SEPTEMBER 30 OF EACH YEAR EXCEPT FOR HUMAN CONSUMPTION, IRRIGATION OF UP TO ONE-HALF ACRE NON-COMMERCIAL GARDEN AND WATERING LIVESTOCK NECESSARY FOR THE SUSTENANCE OF THE FAMILY.

The point of diversion is located as follows:

SW 1/4 NW 1/4, SECTION 18, T 30 S, R 1 W, W.M.; 3 FEET NORTH AND 785 FEET EAST FROM THE WEST QUARTER CORNER OF SECTION 18.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4
SECTION 18
TOWNSHIP 30 SOUTH, RANGE 1 WEST, W.M.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
