CERTIFICATE OF WATER RIGHT

CANCELED

THIS CERTIFICATE ISSUED TO
MOUNTAIN LAKES BIBLE CAMP
2244 WIARD STREET
KLAMATH FALLS, OREGON 97601

confirms the right to use the waters of VARNEY CREEK, a tributary of
FOURMILE CREEK, for FIRE PROTECTION.

This right was perfected under Permit 27174. The date of priority is
FEBRUARY 7, 1961. This right is limited to 0.07 CUBIC FOOT PER SECOND
or its equivalent in case of rotation, measured at the point of
diversion from the source.

The point of diversion is located as follows:

NW 1/4 NE 1/4, SECTION 28, T 36 S, R 6 E, W.M.; 690 FEET SOUTH
AND 50 FEET EAST FROM THE NORTH 1/4 CORNER OF SECTION 28.

The use shall conform to such reasonable rotation system as may be
ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is
as follows:

SE 1/4 SW 1/4
SW 1/4 SE 1/4
SECTION 21
TOWNSHIP 36 SOUTH, RANGE 6 EAST, W.M.

The following provisions shall be effective when in the judgment of the
Watermaster it becomes necessary to install headgates and measuring
devices:

the diversion works shall include an in-line flow meter, a
weir, or other suitable device for measuring the water to
which the wateruser is entitled;

the type and plans of the measuring device be approved by the
Watermaster before the beginning of construction work and that
the weir or measuring device be installed under the general
supervision of said Watermaster.

This certificate is issued to confirm a change in USE approved by an
order of the Water Resources Director entered APRIL 27, 1983, and
supersedes Certificate 31067, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status
of the water right in regard to the provisions of ORS 540.610 pertaining
to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to
beneficial use on the lands or place of use described. The use
confirmed herein may be made only at times when sufficient water is
available to satisfy all prior rights, including rights for maintaining
instream flows.
