CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of THE CALAPOOIA RIVER, a tributary of THE WILLAMETTE RIVER, for the purpose of MUNICIPAL USE.

This right has been perfected under Permit 27871. The date of priority is FEBRUARY 23, 1962. This right is limited to 0.67 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source when available at original point of diversion; SW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 51, SECTION 31, T 13 S, R 2 W, W.M.; NORTH 71 DEGREES EAST 1600 FEET FROM THE SW CORNER OF SECTION 31.

The point of diversion is located as follows:

SW 1/4 SW 1/4, AS PROJECTED WITHIN A. KIRK DLC 37, SECTION 31, T 13 S, R 2 W, W.M.; 500 FEET NORTH AND 30 FEET EAST FROM THE SW CORNER OF SECTION 31.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

The following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 1, 1983, and supersedes certificate 33735, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
