confirms the right to use the waters of A WELL in the BUTTER CREEK BASIN for IRRIGATION OF 111.54 ACRES AND SUPPLEMENTAL IRRIGATION OF 288.3 ACRES.

This right was perfected under Permit U-425. The date of priority is MARCH 4 1952. This right is limited to 4.44 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
