The date of priority is 1883 FOR 5.01 CUBIC FEET PER SECOND; 1895 FOR 6.40 CUBIC FEET PER SECOND; AND 1903 FOR 1.5 CUBIC FEET PER SECOND.

The use is limited to 12.91 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.
