## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the BUTTER CREEK BASIN for SUPPLEMENTAL IRRIGATION OF 892.6 ACRES.

This right was perfected under Permit G-7145. The date of priority is NOVEMBER 15.1976. This right is limited to 6.14 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 3 SE 3, SECTION 15, T 2 N, R 27 E, W.M.; 1380 FEET NORTH AND 210 FEET WEST FROM THE SE CORNER OF SECTION 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
