confirms the right to use the waters of 4 WELLS in the DESCHUTES BASIN for the purpose of IRRIGATING 38.6 ACRES.

This right has been perfected under Permit G-8698. The date of priority is JUNE 19, 1979. This right is limited to 0.48 CUBIC FOOT PER SECOND, BEING 0.45 CFS FROM WELLS 5, 6, AND 11 AND 0.03 CFS FROM WELL 12, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

(WELL 5) NE 1/4 NE 1/4, SECTION 20, T 14 S, R 12 E, W.M.; 300 FEET SOUTH AND 40 FEET WEST; (WELL 6) NE 1/4 NE 1/4, SECTION 20, T 14 S, R 12 E, W.M.; 1260 FEET SOUTH AND 40 FEET WEST, BOTH FROM THE NE CORNER OF SECTION 20. (WELL 11) SW 1/4 SW 1/4, SECTION 21, T 14 S, R 12 E, W.M.; 350 FEET NORTH AND 400 FEET EAST FROM THE SW CORNER OF SECTION 21. (WELL 12) NW 1/4 NE 1/4, SECTION 21, T 14 S, R 12 E,; 550 FEET SOUTH AND 120 FEET EAST FROM THE N 1/4 CORNER OF SECTION 21.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
