CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A SUMP in the SPRAGUE RIVER BASIN for IRRIGATING 141.1 ACRES.

This right was perfected under Permit G-7084. The date of priority is JUNE 1, 1976. This right is limited to 1.76 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The sump is located as follows:

NE 1/4 NE 1/4, SECTION 30, T 35 S, R 10 E, W.M.; 950 FEET SOUTH AND 810 FEET WEST FROM NORTHEAST CORNER OF SECTION 30.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year AND SHALL BE FURTHER LIMITED TO APPROPRIATION OF WATER ONLY TO THE EXTENT THAT IT DOES NOT IMPAIR OR SUBSTANTIALLY INTERFERE WITH EXISTING SURFACE WATER RIGHTS OF OTHERS.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
