CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARVIN C. JENKINS
880 MARROW ROAD
INDEPENDENCE, OREGON 97351

confirms the right to use the waters of RICKREALL CREEK, a tributary of WILLAMETTE RIVER, for IRRIGATING 69.8 ACRES.

This right was perfected under Permit 12571. The date of priority is MARCH 12, 1937. This right is limited to 0.88 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4, NE 1/4 NW 1/4, BOTH AS PROJECTED WITHIN DLC 48, SECTION 33, T 7 S, R 4 W, W.M.; 125 FEET SOUTH AND 250 FEET EAST, 50 FEET SOUTH AND 1170 FEET WEST, BOTH FROM THE N 1/4 CORNER OF SECTION 33.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4	14.40 ACRES
NW 1/4 SW 1/4	4.55 ACRES
SW 1/4 SW 1/4	4.90 ACRES

SECTION 33
TOWNSHIP 7 SOUTH, RANGE 4 WEST, W.M.

NE 1/4 NW 1/4	9.00 ACRES
NW 1/4 NW 1/4	1.20 ACRES

BOTH AS PROJECTED WITHIN DLC 38
SECTION 4
TOWNSHIP 8 SOUTH, RANGE 4 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JULY 25, 1989, approving TRANSFER 6266 and the lands not involved in the order, supersedes Certificate 61987, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
