CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DANIEL HERMAN AND BARBARA ELAINE CLARK  
23324 WOODS CREEK ROAD  
PHILOMATH, OREGON 97370

confirms the right to use the waters of AN UNNAMED STREAM AND WOODS CREEK, a tributary of MARYS RIVER, for DOMESTIC USE FOR ONE FAMILY FROM THE UNNAMED STREAM AND 1.9 ACRES OF IRRIGATION FROM WOODS CREEK.

This right was perfected under Permit 50197. The date of priority is AUGUST 27, 1987. This right is limited to 0.029 CUBIC FOOT PER SECOND, BEING 0.005 CFS FOR DOMESTIC USE FROM THE UNNAMED STREAM; AND 0.024 CFS FOR IRRIGATION FROM WOODS CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 3 (SW 1/4 NE 1/4) SECTION 8, T 12 S, R 6 W, W.M.; DIVERSION 1 - (UNNAMED STREAM) 92 FEET SOUTH AND 3330 FEET WEST; DIVERSION 2 - (WOODS CREEK) 5 FEET SOUTH AND 3510 FEET WEST; BOTH FROM THE SOUTHEAST CORNER OF DLC 75.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NE 1/4 0.7 ACRE  
LOT 3 (SW 1/4 NE 1/4) 1.2 ACRES AND DOMESTIC  
SECTION 8  
TOWNSHIP 12 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
