CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of THREE WELLS in the FORT ROCK BASIN for the purpose of IRRIGATING 511.4 ACRES.

The right has been perfected under Permit G-7170. The date of priority is FEBRUARY 11, 1977. The right is limited to not more than 6.40 CUBIC FEET PER SECOND, BEING 2.95 CFS FROM WELL 1; 1.78 CFS FROM WELL 2 AND 1.67 CFS FROM WELL 3 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 1 - NW 1/4 NE 1/4; WELL 2 - NE 1/4 SE 1/4; WELL 3 - SE 1/4 SW 1/4, SECTION 16, T 28 S, R 16 E, W.M.; WELL 1 - 1290 FEET SOUTH AND 1330 FEET WEST FROM NE CORNER SECTION 16; WELL 2 - 1350 FEET NORTH AND 1190 FEET WEST; WELL 3 - 1300 FEET NORTH AND 3840 FEET WEST, BOTH FROM SE CORNER SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
