CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STANFORD BUELL PO BOX 6 DILLARD, OREGON 97432

confirms the right to use the waters of WEST AND EAST STREAMS AND FOUR RESERVOIRS CONSTRUCTED UNDER PERMIT NUMBERS R-5632 AND R-5624, tributaries of MASTERS CREEK, for IRRIGATING 123.7 ACRES.

This right was perfected under Permit 35121. The date of priority is JANUARY 7, 1971. This right is limited to 1.54 CUBIC FEET PER SECOND, BEING 0.32 CFS FROM WEST UNNAMED STREAM AND RESERVOIRS A AND B; 0.26 CFS FROM EAST UNNAMED STREAM AND RESERVOIR C; AND 0.96 CFS FROM EAST UNNAMED STREAM AND RESERVOIR D, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

RESERVOIR C AND E STREAM - NW 1/4 NW 1/4, RESERVOIR D AND E STREAM - SE 1/4 NW 1/4, BOTH AS PROJECTED WITHIN THE N SAXTON DLC 38, SECTION 5, RESERVOIRS A AND B AND W STREAM - NE 1/4 NE 1/4 AS PROJECTED WITHIN THE H SAXTON DLC 37, SECTION 6, T 28 S, R 6 W, W.M., RESERVOIR A - 1890 FEET NORTH AND 2450 FEET WEST, RESERVOIR B - 1670 FEET NORTH AND 2400 FEET WEST, RESERVOIR C 1160 FEET NORTH AND 1320 FEET WEST, RESERVOIR D - 330 FEET NORTH AND 370 FEET WEST, ALL FROM THE SE CORNER, N SAXTON DLC 38.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
