confirms the right to use the waters of CROOKED RIVER, a tributary of DESCHUTES RIVER, for the purpose of IRRIGATION OF 44.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 26.9 ACRES.

The right has been perfected under Permit 42025. The date of priority is JANUARY 2, 1976. The right is limited to not more than 1.8 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

1 - NE 1/4 SW 1/4; 2 - SW 1/4 NE 1/4, SECTION 19, T 16 S, R 19 E, W.M.; DIVERSION POINT 1 LOCATED 1850 FEET NORTH AND 2700 FEET WEST, DIVERSION POINT 2 LOCATED 2700 FEET NORTH AND 2200 FEET WEST; BOTH FROM THE SE CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
