## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GORDON W. AND DEBORAH S. SUMMERS 306-N HAYDEN BAY DRIVE PORTLAND, OREGON 97217

confirms the right to use the waters of AN UNNAMED STREAM, a tributary of DRY CREEK, for IRRIGATION OF 10.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 4.3 ACRES.

This right was perfected under Permit 50923. The date of priority is OCTOBER 5, 1987 FOR 0.165 CFS AND MARCH 17, 1988 FOR 0.205 CFS. This right is limited to 0.37 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, SECTION 11, T 8 S, R 46 E, W.M.; 2900 FEET NORTH AND 706 FEET WEST FROM THE SE CORNER OF SECTION 11.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
