## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES W. MASON 4268 LAUREL RIDGE DRIVE ALLISON PARK, PA 15101

confirms the right to use the waters of 2 WELLS in the MALHEUR LAKE BASIN for IRRIGATING 161.1 ACRES.

This right was perfected under Permit G-10340. The date of priority is JANUARY 20, 1984. This right is limited to 2.01 CUBIC FEET PER SECOND, IF AVAILABLE AT THE ORIGINAL WELL, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 SE 1/4, SECTION 30, T 24 S, R 32 1/2 E, W.M.; 30 FEET NORTH AND 560 FEET WEST FROM THE SE CORNER OF SECTION 30.

NE 1/4 NE 1/4, SECTION 31, T 24 S, R 32 1/2 E, W.M.; 799 FEET SOUTH AND 1151 FEET WEST FROM THE NE CORNER OF SECTION 31.

The quantity of water diverted at the new well together with the quantity of water diverted from the original well shall not exceed the quantity of water available from the original well.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

Water shall be acquired from the same aquifer as the original point of appropriation.

When required by the Department the water user shall install in-line flow meters or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall installed under the general supervision of the Department.

This certificate is issued to confirm a change for AN ADDITIONAL POINT OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered MARCH 6, 1991, and supersedes Certificate 60872, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
