CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of DISSEL CREEK, JOHN DAY RIVER AND SPRINGS IN N $\frac{1}{2}$ N $\frac{1}{2}$ SECTION 28, NE $\frac{1}{4}$ NE $\frac{1}{4}$ SECTION 29, N $\frac{1}{2}$ SW $\frac{1}{4}$ SECTION 20, T 13 S, R 32 E, W.M., a tributary of COLUMBIA RIVER, for IRRIGATION OF 290.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at Page 461. The date of priority is 1868.

The use is limited to:

<u>Dissel Creek and Springs</u>: 1/40 cubic foot per second per acre irrigated to June 1 and 1/80 cubic foot per second per acre thereafter; further limited to one acre-foot per calendar month to June 1 and four acre-feet per acre during season April 1 to September 30;

<u>John Day River</u>: 1/40 cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acre-foot per acre per calendar month to July 1 and 3/4 acre-foot per acre thereafter; total five acre-feet per acre for season;

or its equivalent in case of rotation, measured at the point of diversion from the source.

A description of the place of use to which this right is appurtenant is as follows:
