CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of 13 WELLS in the PACIFIC OCEAN BASIN for IRRIGATION OF 19.0 ACRES AND AIR TEMPERATURE CONTROL.

This right was perfected under Permit G-10121. The date of priority is JUNE 30, 1983. This right is limited to 0.48 CUBIC FOOT PER SECOND FROM WELLS 12, 13, AND 14, WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM WELLS 12, 13, AND 14 TO BE MADE UP BY APPROPRIATION FROM WELLS 1 THROUGH 10; BEING 0.24 CFS FOR IRRIGATION AND 0.48 CFS FOR AIR TEMPERATURE CONTROL or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NW 1/4 NW 1/4 AND SW 1/4 NW 1/4, SECTION 15, AND NE 1/4 NE 1/4 AND NW 1/4 NE 1/4, SECTION 16, T 41 S, R 13 W, W.M.; WELL 1 - 680 FEET SOUTH AND 15 FEET WEST; WELL 2 - 520 FEET SOUTH AND 310 FEET WEST; WELL 3 - 1120 FEET SOUTH AND 270 FEET WEST; WELL 4 - 790 FEET SOUTH AND 190 FEET EAST; WELL 5 - 1120 FEET SOUTH AND 50 FEET WEST; WELL 6 - 840 FEET SOUTH AND 200 FEET WEST; WELL 7 - 1120 FEET SOUTH AND 220 FEET EAST; WELL 8 - 215 FEET SOUTH AND 1450 FEET WEST; WELL 9 - 20 FEET SOUTH AND 1610 FEET WEST; WELL 10 - 565 FEET SOUTH AND 1610 FEET WEST; WELL 12 - 1560 FEET SOUTH AND 775 FEET EAST; WELL 13 - 1920 FEET SOUTH AND 505 FEET EAST; WELL 14 - 1100 FEET SOUTH AND 850 FEET EAST; ALL FROM THE SOUTHEAST CORNER OF SECTION 9.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

AS PROJECTED WITHIN DLC 42

NW 1/4 NW 1/4 6.3 ACRES
SW 1/4 NW 1/4 7.3 ACRES
BOTH AS PROJECTED WITHIN DLC 43
SECTION 15
TOWNSHIP 41 SOUTH, RANGE 13 WEST, W.M.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
