confirms the right to use the waters of THE UMPQUA RIVER, a tributary of THE PACIFIC OCEAN, for IRRIGATING 265.9 ACRES.

This right was perfected under Permit 39672. The date of priority is DECEMBER 6, 1974. This right is limited to 3.32 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

DIVERSION POINT 1 - NE 1/4 SE 1/4, SECTION 36, T 22 S, R 8 W, W.M.; 2850 FEET SOUTH AND 700 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 36; DIVERSION POINT 2 - NE 1/4 NW 1/4, SECTION 31, T 22 S, R 7 W, W.M.; 700 FEET SOUTH AND 2350 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 31; DIVERSION POINT 3 - SW 1/4 SE 1/4, SECTION 30, T 22 S, R 7 W, W.M.; 720 FEET NORTH AND 3230 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 30.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
