CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EAST MUD CREEK WATER USERS DISTRICT  
ROUTE 2, BOX 257  
MILTON-FREEWATER, OREGON 97862

confirms the right to use the waters of THE LITTLE WALLA WALLA RIVER, WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE LITTLE WALLA WALLA RIVER TO BE MADE UP BY DIVERSION FROM THE WALLA WALLA RIVER, tributaries of the COLUMBIA RIVER, for the purpose of the SUPPLEMENTAL IRRIGATION OF 146.4 ACRES.

This right has been perfected under Permit 43095. The date of priority is APRIL 4, 1977. This right is limited to 4.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NE 1/4, SECTION 27, T 6 N, R 35 E, W.M.; POD 2 - (FRUIT VALE DITCH) 1980 FEET SOUTH AND 2180 FEET EAST FROM THE N 1/4 CORNER OF SECTION 27; SW 1/4 NE 1/4, SECTION 12, T 5 N, R 35 E, W.M.; POD 1 - (WALLA WALLA RIVER) 960 FEET NORTH AND 850 FEET EAST FROM THE CENTER QUARTER CORNER OF SECTION 12.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 0.0375 of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
