## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENNETH L. & KAREN L. TUTTLE 1696 COVE POINT ROAD KLAMATH FALLS, OREGON 97601

confirms the right to use the waters of TWO SPRINGS, tributaries of THE WILLIAMSON RIVER, for IRRIGATING 69.3 ACRES, BEING 7.3 ACRES FROM SPRING #1 AND 62.0 ACRES FROM SPRING #2.

This right was perfected under Permit 45127. The date of priority is JULY 8, 1980. This right is limited to 1.73 CUBIC FEET PER SECOND, BEING 0.18 CFS FROM SPRING #1 AND 1.55 CFS FROM SPRING #2, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SPRING #2- SW 1/4 SW 1/4, SECTION 11; SPRING #1- SW 1/4 SW 1/4, SECTION 14, BOTH IN T 34 S, R 7 E, W.M.; SPRING #2- 350 FEET NORTH AND 1200 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 11; SPRING #1-700 FEET NORTH AND 200 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 14

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
