CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VIRGINIA GLASER

confirms the right to use the waters of ONE WELL in the CALAPOOYA RIVER BASIN for IRRIGATION OF 75.7 ACRES.

This right was perfected under Permit G-9139. The date of priority is JANUARY 6, 1981. This right is limited to 0.39 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NW 1/4, SECTION 34, T 12 S, R 3 W, W.M.; 70 FEET NORTH AND 2560 FEET EAST FROM THE WEST QUARTER CORNER OF SECTION 34.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 NW 1/4 16.0 ACRES
NW 1/4 NW 1/4 35.5 ACRES
SW 1/4 NW 1/4 24.2 ACRES
SECTION 34
TOWNSHIP 12 SOUTH, RANGE 3 WEST, W.M.

The following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered APRIL 3, 1987 and together with Certificate 56233 supersedes Certificate 53881, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
