CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN HYLAND 40814 MCKENZIE HIGHWAY SPRINGFIELD, OREGON 97478

confirms the right to use the waters of MCKENZIE RIVER, a tributary of WILLAMETTE RIVER, for IRRIGATION OF 1.88 ACRES.

This right was perfected under Permit 51152. The date of priority is SEPTEMBER 12, 1990. This right is limited to 0.024 CUBIC FOOT PER SEPTEMBER 12, 1990. This right is limited to 0.024 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 24, T 17 S, R 1 W, W.M.; 238 FEET SOUTH AND 276 FEET WEST FROM CENTER 1/4 CORNER OF SECTION 24.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SECTION 24

TOWNSHIP 17 SOUTH, RANGE 1 WEST, W.M.

Diversion screening or fish passage facilities shall be maintained, and operated to Oregon Department of Fish & Wildlife specifications.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
