CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ERNEST O'DEANE FARIS 1812 SW 45TH STREET PENDLETON, OREGON 97801

confirms the right to use the waters of A WELL in the MCKAY CREEK BASIN for PRIMARY IRRIGATION OF 10.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 3.1 ACRES.

This right was perfected under Permit G-5470. The date of priority is NOVEMBER 18, 1974. This right is limited to 0.17 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well. THE QUANTITY OF WATER APPROPRIATED AT THE NEW WELL TOGETHER WITH THAT APPROPRIATED FROM THE OLD WELL SHALL NOT EXCEED THE QUANTITY OF WATER AVAILABLE AT THE ORIGINAL WELL.

The well shall produce water only from the basalt ground water reservoir.

The well is located as follows:

LOT 16 (SE 1/4 SE 1/4), SECTION 1, T 1 S, R 32 E, W.M.; 358 FEET NORTH AND 343 FEET WEST FROM THE SE CORNER OF SECTION 1.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MARCH 30, 1988, and together with Certificate 57570 supersedes Certificate 54732, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
