CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A SUMP in the FLORAS CREEK BASIN for SUPPLEMENTAL SUPPLY FOR IRRIGATION, CRANBERRY IRRIGATION, TEMPERATURE CONTROL, AND FLOOD HARVESTING.

This right was perfected under Permit G-9831. The date of priority is AUGUST 25, 1981. This right is limited to 2.18 CUBIC FEET PER SECOND, BEING 0.36 CFS FOR SUPPLEMENTAL CRANBERRY IRRIGATING ON 14.5 ACRES, 2.18 CFS FOR SUPPLEMENTAL SUPPLY FOR TEMPERATURE CONTROL ON 14.5 ACRES, 0.73 CFS FOR SUPPLEMENTAL SUPPLY FOR FLOOD HARVESTING ON 14.5 ACRES, AND 0.34 CFS FOR SUPPLEMENTAL IRRIGATION ON 27.4 ACRES or its equivalent in case of rotation, measured at the well.

The sump is located as follows:

NE 1/4 SW 1/4, SECTION 9, T 31 S, R 15 W, W.M.; 2100 FEET NORTH AND 1600 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 9.

The amount of water diverted for CRANBERRY OPERATIONS, together with amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre; For flood harvesting or pest control, 0.05 cubic foot per second per acre; For irrigation of cranberries, ONE-FORTIETH of one cubic foot per second and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, ONE-EIGHTIETH of one cubic foot per second and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 NW 1/4 4.0 ACRES - SUPPLEMENTAL IRRIGATION
NE 1/4 SW 1/4 14.5 ACRES HARVEST, CRANBERRIES, TEMPERATURE CONTROL
NW 1/4 SW 1/4 23.4 ACRES - SUPPLEMENTAL IRRIGATION
 SECTION 9
TOWNSHIP 31 SOUTH, RANGE 15 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
