CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALAN ARTHUR HAGA ROUTE 1, BOX 1553 BANDON, OREGON 97411

confirms the right to use the waters of AN UNNAMED STREAM, WILLOW CREEK AND FLORAS CREEK, a tributary of PACIFIC OCEAN, for IRRIGATION, SUPPLEMENTAL IRRIGATION, TEMPERATURE CONTROL, AND FLOOD HARVESTING OF CRANBERRIES.

This right was perfected under Permit 46891. The date of priority is AUGUST 25, 1981. This right is limited to 2.18 CUBIC FEET PER SECOND FROM UNNAMED STREAM WHEN AVAILABLE FROM UNNAMED STREAM WITH ANY DEFICIENCIES IN THE AVAILABLE SUPPLY FROM THE UNNAMED STREAM TO BE MADE UP BY APPROPRIATOR FROM WILLOW CREEK AND FLORAS CREEK, BEING 0.36 FOR CRANBERRY IRRIGATING ON 14.5; 2.18 CFS FOR TEMPERATURE CONTROL ON 14.5 ACRES, 0.73 CFS FOR FLOOD HARVESTING ON 14.5 ACRES, 0.34 CFS FOR IRRIGATING 27.4 ACRES, AND 0.86 CFS FOR SUPPLEMENTAL IRRIGATING 68.5 ACRES;

1.44 CFS FROM FLORAS CREEK, BEING 0.36 CFS FOR SUPPLEMENTAL CRANBERRY IRRIGATING ON 14.5 ACRES; 2.18 CFS FOR SUPPLEMENTAL SUPPLY FOR TEMPERATURE CONTROL ON 14.5 ACRES, 0.73 CFS FOR SUPPLEMENTAL SUPPLY FOR FLOOD HARVESTING ON 14.5 ACRES, 0.34 CFS FOR SUPPLEMENTAL IRRIGATING 27.4 ACRES;

AND 0.92 CUBIC FOOT PER SECOND FROM WILLOW CREEK, BEING 0.36 FOR SUPPLEMENTAL CRANBERRY IRRIGATING ON 14.5 ACRES, 0.67 CFS FOR SUPPLEMENTAL SUPPLY FOR TEMPERATURE CONTROL ON 14.5 ACRES, 0.63 CFS FOR SUPPLEMENTAL SUPPLY FOR FLOOD HARVESTING ON 14.5 ACRES; 0.34 CFS FOR SUPPLEMENTAL IRRIGATING ON 27.4 ACRES, AND 0.22 CFS FOR IRRIGATING 17.4 ACRES, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NW 1/4 AND NE 1/4 SE 1/4, SECTION 9, AND SW 1/4 SW 1/4, SECTION 4; T 31 S, R 15 W, W.M.; UNNAMED STREAM - 2620 FEET SOUTH AND 1750 FEET EAST FROM NW CORNER OF SECTION 9; WILLOW CREEK - 2220 FEET NORTH AND 1280 FEET WEST FROM SE CORNER OF SECTION 9; FLORAS CREEK - 1000 FEET NORTH AND 110 FEET EAST FROM SW CORNER OF SECTION 4.

The amount of water diverted for CRANBERRY OPERATIONS, together with amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre; For flood harvesting or pest control, 0.05 cubic foot per second per acre; For irrigation of cranberries, ONE-FORTIETH of one cubic foot per second and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, ONE-EIGHTIETH of one cubic foot per second and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
