CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the MILL CREEK BASIN for IRRIGATING 75.5 ACRES AND RELATED NURSERY USES.

This right was perfected under Permit G-10599. The date of priority is APRIL 1, 1986. This right is limited to 1.10 CUBIC FEET PER SECOND, BEING 0.94 CFS FOR IRRIGATION AND 1.10 CFS FOR RELATED NURSERY USES or its equivalent in case of rotation, measured at the well.

The well is located as follows:

LOT 1 (NE 1/4 NW 1/4), SECTION 25, T 5 S, R 2 W, W.M.; 830 FEET SOUTH AND 1020 FEET EAST FROM THE MOST SOUTHERLY SW CORNER OF DLC 93.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. THE USE ALLOWED HEREIN FOR IRRIGATION MAY BE MADE ANY TIME BETWEEN APRIL 1 AND NOVEMBER 1 OF EACH YEAR THAT WATER CAN BE PUT TO BENEFICIAL USE BY IRRIGATION FOR IMMEDIATE CROP GROWTH.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
