CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SILETZ RIVER, a tributary of PACIFIC OCEAN, for IRRIGATION OF 16.0 ACRES AND LIVESTOCK.

This right was perfected under Permit 50528. The date of priority is NOVEMBER 25, 1987, FOR 30 GALLONS PER MINUTE FOR IRRIGATION; NOVEMBER 21, 1988, FOR 59.8 GPM FOR IRRIGATION AND JANUARY 19, 1989, FOR 0.5 GPM FOR LIVESTOCK. This right is limited to 90.3 GALLONS PER MINUTE, BEING 89.8 GPM FOR IRRIGATION AND OUT OF SEASON IRRIGATION AND 0.5 GPM FOR LIVESTOCK or its equivalent in case of rotation, measured at the point of diversion from the source. THE USE ALLOWED HEREIN FOR IRRIGATION MAY BE MADE ANYTIME BETWEEN APRIL 1 AND NOVEMBER 30 OF EACH YEAR WHEN WATER CAN BE PUT TO BENEFICIAL USE FOR IMMEDIATE PLANT GROWTH.

The point of diversion is located as follows:

NW 1/4 NE 1/4, SECTION 4, T 10 S, R 9 W, W.M.; 175 FEET SOUTH AND 750 FEET EAST OF THE 1/4 CORNER COMMON TO SECTION 33 AND SECTION 4.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the PERIOD FROM APRIL 1 TO SEPTEMBER 30, AND SHALL BE FURTHER LIMITED TO A DIVERSION OF NOT TO EXCEED 0.5 ACRE FOOT PER ACRE FOR EACH ACRE IRRIGATED DURING THE PERIOD FROM OCTOBER 1 TO NOVEMBER 30, PROVIDED FURTHER THE RIGHT ALLOWED HEREIN, TOGETHER WITH THE AMOUNT SECURED UNDER ANY OTHER RIGHT EXISTING FOR THE SAME LAND SHALL NOT EXCEED 2 1/2 ACRE-FEET FOR EACH ACRE IRRIGATED IN ANY ONE YEAR.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4 6.9 ACRES AND STOCK
SECTION 33
TOWNSHIP 9 SOUTH, RANGE 9 WEST, W.M.

NW 1/4 NE 1/4 9.1 ACRES AND STOCK
SECTION 4
TOWNSHIP 10 SOUTH, RANGE 9 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
