confirms the right to use the waters of SQUAW CREEK, a tributary of the DESCHUTES RIVER, for IRRIGATION OF 185.5 ACRES.

This right was perfected under Permit E-6. The date of priority is APRIL 12, 1909. This right is limited to 2.41 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 3529, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered FEBRUARY 19, 1993, canceling a portion of said water right.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights
