confirms the right to use the waters of SQUAW CREEK, a tributary of the
DESCHUTES RIVER, for IRRIGATION OF 185.5 ACRES.

This right was perfected under Permit E-6. The date of priority is
APRIL 12, 1909. This right is limited to 2.41 CUBIC FEET PER SECOND or
its equivalent in case of rotation, measured at the point of diversion
from the source.

The use shall conform to such reasonable rotation system as may be
ordered by the proper state officer.
