and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Yemhill Record of the STATE ENGINEER, in Volume 8 , at page 369 ; that the priority of the right thereby confirmed dates from that said right exists by virtue of ownership of land riparian to said stream, and is held in common with the rights of other riparian owners as determined by said decree;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

amount which may be reasonably and beneficially used for said purpose;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

A description of the land in connection with which said right has been decreed, is as follows:

> SEISE of Section 5, T. 3 S. R. 2 W.W.M. Being a part of the James Badley and Almeda Badley Donation land Claim Notification # 6388 in Section 4 and 5, Township 3 South of Range 2, West of the Willamette Meridian and State of Oregon and more fully described as: Beginning at the Southeast corner of Section 5 of said Township and Range and rumming thence North 39.86 chains; thence Nest 10.75 chains; thence South 11.80 chains to tract sold to City of Newberg; thence South 75 degrees East 2.23 chains; thence South 59 degrees 45' East 2.01 chains; thence South 4 degrees 15' East 3.72 chains; thence North 37 degrees 15' East 2.10 chains; thence South 621 degrees, East 0.76 chains; thence South 31 degrees 25 ' West 2.40 chains; thence South 54 degrees 6' West 2.50 chains; thence South 17 degrees 36' West 3.392 chains; thence South 41 degrees, West 3.242 chains; thence south 13.65 chains to South boundary of said Badley D.L.J., thence East 9.50 chains to place of beginning and containing Thirty-four (34) acres more or less. Also including the privilege of stock water purposes to a strip 4 rods North and South, be-ginning at the Southwest corner of the tract of land conveyed and running thence to center of the creek.

And said right shall be subject to all other conditions and limitations contained "in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
