CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OTTO AND MAE WEINHOLD
3978 DELANEY ROAD SE
SALEM, OREGON 97301

confirms the right to STORE THE WATERS OF AN UNNAMED DRAINAGEWAY IN TWO EXCAVATED RESERVOIRS, a tributary of BATTLE CREEK, FOR LIVESTOCK.

The right to store these waters was perfected under Reservoir Permit R-11345. The date of priority is MAY 23, 1990. The amount of water entitled to be stored each year under this right is 3.6 acre-feet, BEING 1.3 AF IN NORTH POND AND 2.3 AF IN SOUTH POND.

The ponds are located as follows:

NE 1/4 NW 1/4, SE 1/4 NW 1/4, SECTION 31, T 8 S, R 2 W, W.M.;
NORTH POND - 665 FEET SOUTH AND 390 FEET WEST; SOUTH POND - 1540 FEET
SOUTH AND 400 FEET WEST, BOTH FROM THE N 1/4 CORNER OF SECTION 31.

The area to be submerged by ponds are located within:

NE 1/4 NW 1/4 NORTH POND
SE 1/4 NW 1/4 SOUTH POND
SECTION 31
TOWNSHIP 8 SOUTH, RANGE 2 WEST, W.M.

Use under this right is limited to the reservoir area. This right does not provide for the appropriation of water for maintaining the water level or maintaining a suitable fresh water condition.

When in the judgement of the Watermaster it becomes necessary to regulate waters of the stream system, storage of water in the reservoir shall be subject to the installation of suitable devices for measuring all incoming natural flows and outflows from the reservoir or passing all incoming natural flows. The types and plans for such devices shall be approved by the Watermaster and shall be installed under the general supervision of said Watermaster.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provision of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The storage of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The right to store and use the water for the above purpose is restricted to beneficial use at the place of use described.
