confirms the right to use the waters of ONE WELL in the WILLAMETTE RIVER BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 132.67 ACRES.

This right has been perfected under Permit G-5500. The date of priority is DECEMBER 14, 1971. This right is limited to 1.65 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NE 1/4, SECTION 26, T 3 S, R 1 W, W.M.; 1590 SOUTH AND 50 FEET WEST FROM THE NE CORNER OF SECTION 26.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
