CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GREEN VILLA FARMS 5605 HALLS FERRY ROAD INDEPENDENCE, OREGON 97351

confirms the right to use the waters of THREE WELLS in the WILLAMETTE RIVER BASIN for IRRIGATION OF 118.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 123.1 ACRES.

This right was perfected under Permit G-8684. The date of priority is APRIL 3, 1978. This right is limited to 3.02 CUBIC FEET PER SECOND, BEING 0.28 CFS FROM WELL 3, 0.82 CFS FROM WELL 5, AND 1.92 CFS FROM WELL 7 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 3 - NW 1/4 NW 1/4, SECTION 11, T 8 S, R 4 W, W.M.; 865 FEET SOUTH AND 700 FEET EAST; WELL 5 - SE 1/4 SW 1/4, SECTION 2, T 8 S, R 4 W, W.M.; 1310 FEET NORTH AND 2050 FEET EAST; WELL 7 - NE 1/4 SW 1/4, SECTION 2, T 8 S, R 4 W, W.M.; 1525 FEET NORTH AND 1485 FEET EAST, ALL FROM THE SW CORNER OF SECTION 2.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
