## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN AND DORIS KOKKELER 27599 COX BUTTE ROAD JUNCTION CITY, OREGON 97448

confirms the right to use the waters of THE LONG TOM RIVER AND FERN RIDGE RESERVOIR CONSTRUCTED UNDER PERMIT R-1625, a tributary of THE WILLAMETTE RIVER, for IRRIGATION OF 74.4 ACRES.

This right was perfected under Permit 51159. The date of priority is JULY 2, 1990. This right is limited to 0.93 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

FERN RIDGE DAM - SE 1/4, SECTION 4, T 17 S, R 5 W, W.M.

DIVERSION POINT "A" - SE 1/4 NW 1/4, SECTION 26, T 15 S, R 5 W, W.M.; 1294.33 FEET NORTH AND 3983.72 FEET WEST OF THE EAST 1/4 CORNER OF SECTION 26.

DIVERSION POINT "B" - NW 1/4 NW 1/4, SECTION 26, T 15 S, R 5 W, W.M.; 2679.69 FEET NORTH AND 4152.76 FEET WEST OF THE EAST 1/4 CORNER OF SECTION 26.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 NW 1/4 39.4 ACRES NW 1/4 NW 1/4 1.0 ACRE SE 1/4 NW 1/4 8.0 ACRES SECTION 26

NW 1/4 NE 1/4 23.5 ACRES NE 1/4 NW 1/4 2.5 ACRES SECTION 27

TOWNSHIP 15 SOUTH, RANGE 5 WEST, W.M.

The water user shall comply with the terms and conditions of Contract #1-07-10-WO817 dated DECEMBER 13, 1990, between the BUREAU OF RECLAMATION and JOHN AND DORIS KOKKELER. A copy of the CONTRACT is in File 70451 at the Water Resources Department.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.
