CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VERDA CROOK
718 HAYTER STREET
DALLAS, OREGON 97338

confirms the right to use the waters of the LITTLE LUCKIAMUTE RIVER, a tributary of the LUCKIAMUTE RIVER, for IRRIGATION OF 85.9 ACRES.

This right was perfected under Permit 32204. The date of priority is MARCH 13, 1967. This right is limited to 1.08 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within SMITH DLC 50, NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within SMITH DLC 56, SECTION 8, T 9 S, R 5 W, W.M.; 200 FEET NORTH AND 400 FEET EAST, 200 FEET SOUTH AND 1630 FEET EAST, BOTH FROM THE NW CORNER OF DLC 56.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 41885, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered August 26, 1993, 1993, approving Transfer Application 6533.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
