confirms the right to use the waters of the CROOKED RIVER, a tributary of the DESCHUTES RIVER, for 95.2 ACRES, STOCK, AND DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for CROOK County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 449. The date of priority is 1891.

The use is limited to 1.59 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW\(\frac{1}{4}\) SE\(\frac{1}{4}\), SECTION 1, T 16 S, R 15 E, WM; STEARNS DAM - 100 FEET NORTH AND 1500 FEET EAST FROM THE SE CORNER OF SECTION 1; SW\(\frac{1}{4}\), SE\(\frac{1}{4}\), SE\(\frac{1}{4}\), SECTION 36, T 15 S, R 16 E, WM; 9 - 5260 FEET SOUTH AND 1960 FEET WEST; 10 - 1550 FEET SOUTH AND 40 FEET WEST; BOTH FROM THE NE CORNER OF SECTION 36.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second (or its equivalent) and 6.0 acre-feet for each acre irrigated during the irrigation season of each year.
