CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of ONE WELL in the WILLIAMS CREEK BASIN for SUPPLEMENTAL IRRIGATION OF 5.5 ACRES, CONTAINERIZED NURSERY STOCK ON 0.11 ACRE AND GREENHOUSE USE ON 3060 SQUARE FEET.

This right was perfected under Permit G-10887. The date of priority is NOVEMBER 10, 1987. This right is limited to 43.0 GALLONS PER MINUTE, BEING 30.9 GPM FOR SUPPLEMENTAL IRRIGATION, 7.4 GPM FOR CONTAINERIZED NURSERY STOCK, AND 4.7 GPM FOR GREENHOUSE USE, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 NE 1/4, SECTION 33, T 38 S, R 5 W, W.M.; 580 FEET NORTH AND 670 FEET WEST FROM THE SE CORNER OF THE NE 1/4 NE 1/4 OF SECTION 33.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

If used for field irrigation of nursery stock, such use is not restricted to the defined agricultural irrigation season.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall be limited to appropriation of water only to the extent that it does not impair or substantially interfere with prior surface water rights as well as prior ground water rights of others.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 NE 1/4	0.11 ACRE -CONTAINER STOCK
NE 1/4 NE 1/4	0.07 ACRE -GREENHOUSE
SECTION 33	
TOWNSHIP 38 SOUTH, RANGE 5 WEST, W.M.	

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
