CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of ABBELOOS RESERVOIR, CONSTRUCTED UNDER PERMIT R-8309, within MILLER CREEK DRAINAGE, for IRRIGATING 403.6 ACRES.

This right was perfected under Permit 46064. The date of priority is JUNE 11, 1981. This right is limited to 418.0 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NE 1/4, SECTION 16, T 39 S, R 13 E, W.M.; 1230 FEET SOUTH AND 3710 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 16.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
